**LIMITED SUPPLEMENTARY DECLARATION
FOR NATIVE PLAINS, A RESIDENTIAL COMMUNITY TO THE CITY OF
OKLAHOMA CITY, CLEVELAND COUNTY, STATE OF OKLAHOMA.**

THIS LIMITED SUPPLEMENTARY DECLARATION is made this 6th day of November, 2019, by Sweet Grass Communities, L.L.C., an Oklahoma limited liability company ("Declarant").

Section 1 - Purpose of Limited Supplementary Declaration.

Declarant is the Declarant of the Additions comprising Native Plains which is a platted addition more particularly described within Exhibit "A" hereto. The Declarant intends by the Recording of this instrument supplement in a limited fashion the Declaration filed at Book 5622, Page 1446 (Original Declaration) within the Cleveland County Clerk's office for Native Plains, a residential community including any amendments and supplements thereto (Original Declaration). The Declarant executes and adopts this instrument pursuant to its authority granted and reserved within the Original Declaration.

Section 2 - Limited Supplement to Declaration. The following terms, concepts, conditions, and restrictions are added to the Original Declaration:

Declarant has contemporaneously filed with this instrument a Declaration of Covenants, Conditions, and Restrictions for a real estate development named the Springs at Native Plains (the "SNPD"), which is a development adjacent to the Addition but that is separate and distinct from the Addition. Declarant intends, and by this instrument and the SNPD provides, that the community association for the Springs at Native Plains shall remit to the Association on an annual basis the sum of \$1,800.00 per platted lot within the Springs at Native Plains, such sum being designated, its terms, and being more fully described as the NPA within the SNPD.

Section 3 - Additional Declarations.

All other terms and provisions, including but not limited to covenants, conditions, restrictions, definitions, and exhibits found within the Original Declaration and any amendments and supplemental declarations thereto are hereby incorporated by reference as if each were fully set out within this instrument. All such terms and provisions, unless expressly and specifically modified by this instrument, shall remain in effect as first Recorded in the Original Declaration as amended and supplemented, Declarant hereby reaffirming the same.
